As we get into the fall months, please be aware that the village of Clinton follows EPA guidelines when it comes to open burns. Open burns shall be kept to clean dry wood, this means that leaves and yard waste shall not be burned at any point

FULTON MULES VINTAGE BASE BALL CLUB

On Saturday, July 8, during the Old Canal Days Festival the Fulton Mules Vintage Base Ball Club demonstrated the game of base ball as it was played in the 1860s and the height of the Ohio Canal Era. A visiting club from Smithville, the Stars, came to town and played a nine inning contest. The Fulton Mules won by a total of 19 tallies to 2 for the Stars.

The following day the Mules held another demonstration New York Rules of Baseball at the Hoover Park Celebration in North Canton, playing an interclub match where the "Old" Mules squared off against the "Younger" members of the club. The Old timers were victorious by a score of 13 to 8.

Vintage Base Ball is a historical demonstration of the game of base ball that attempts to educate and entertain the spectators on the history of the game and how it was played using the rules and customs from various historic eras.

The Fulton Mules conclude their season on Oct 7th playing at Historic League Park in Cleveland for the Temple Cup. Trustee Talk: From Trustee Keith Blowers **Financials, Levies and Taxes**

I hope everyone had a wonderful summer! Fall is my favorite time of year, but it also comes with some unpleasant side effects like cold weather, rain, and tax levies. Unfortunately, all of these are unavoidable. The township needs your support to provide necessary services to residents. As we have mentioned before, for those in the township, we are the sole provider of local police, fire, EMS, township road, and zoning services.

The attached chart shows our collective property tax revenues which represent the majority of the total budget.

- The exploded slices represent levy funds that are up for replacement in November.
- Combined, they represent 28% of the tax revenue.
- They include two fire levies (1.5 mill combined), one police levy (1.5 mill) and our sole remaining road levy (1 mill)
- We are also asking again to pass a inewî levy to replace the one that previously expired in 2021.
- 1 mill is worth \$35.00 yearly per \$100,000.00 of property valuation.
- Combined, in total, we are asking for 5.65 mills which would cost \$197.75 per year per \$100,000.00 of valuation. You are currently paying \$110.61 (effective rate), the expired levy cost \$49.00, which leaves an increase of \$38.14 (See replacement vs. renewal section).

The bottom line is that Lawrence Township is a great community full of hardworking people. We are very aware of the economic pressure every household is feeling right now and nobody wants to pay more taxes. However, these are services we all NEED. These levies are paying the salaries of people that live and work HERE in our community. Plowing our streets, keeping us safe, and answering the call when you need help. Replacement vs Renewal Levy

The township decided to replace, rather than renew the levies that are on the ballot. When a levy is placed on the ballot the township sets the millage based on the amount of money it would like to generate. Over the lifespan of the levy the effective millage decreases as valuations increase since the levy can't collect more than that original amount. Property owners pay at the effective rate rather than the original mill rate as valuations increase. A renewal would collect the same amount of dollars as when the levy was first passed and is paid at the effective rate; a replacement uses the same terms and conditions as the current levy but updates the amount to the current valuation.

Why do we need this increase? We all understand that everything gets more expensive over time, and the township is not exempt. Items we need most like fuel, road materials, salt, truck maintenance, uniforms and gear, and EMS and fire equipment have all increased in price significantly. In addition, our personnel costs, including wages and insurance, increase over time. We need our revenues to increase with the valuations in order to keep up with rising costs.

General Levy Facts

For those who are not familiar, I want to share a few quick general levy facts. Ohio townships are solely funded through property tax levies and have no ability to tax income like schools or cities. Lawrence Township receives approximately 22 cents for every \$1.00 a property owner pays in property tax to the County. The 22 cents is further divided by district (General, Police, Road, Road & Bridge and Fire) according to the levies. Levies are attached to a certain fund and only permitted to be used for the purposes stated on the ballot. We cannot transfer funds between departments aside from the general fund. In Lawrence Township, salaries, fuel, equipment, and materials represent the overwhelming majority of the expenditures. The trustees work closely with our fiscal officer to do our due diligence in order to prevent any wasteful spending. Our tax budget was passed at the August 7th meeting and is available for review by residents.

ROAD DISTRICT TAX LEVY

As we come into fall, and election time, it is important to discuss our road department and why the upcoming tax levies are so important. Our Road Department currently maintains 57 miles of roadway.

What does our Road Department do?

- Road Maintenance patching, paving and resurfacing roads, snow and ice removal
- Tree Removal from roadways during storms, road sightline obstructions, and tree trimming along roadways
- Road Culverts and Catch Basins clean out, repair, and replacement
- Mowing Roadsides keep roads free of obstructions and sightline clearance
- Ditching and Berming keep the water flowing off the roadway
- Vehicle Maintenance servicing and repairs to equipment
- Road Signs replacing signs that have been damaged or stolen, including stop signs, road signs and street signs
- Guardrail Repair

Prior to 2022, our road district was funded by two tax levies, one of which expired. We are asking for a replacement of the sole remaining road levy, as well as a "new" levy to replace the one that expired in 2021. Below is an outline of road district expenditures from 2021 and 2022.

While budget cuts can be good fiscally, in this case it is hurting the service provided to residents. The reduction in material purchases represents a reduction in repairs and resurfacing done to our roadways. No capital spending means our trucks, plows, and mowers are not being replaced. We currently have two plow/salt trucks that are over ten years old and will need to be replaced soon. Even if we purchased now, a replacement would take two years to receive. Previously, we had four road department employees, now we have three. This means each plow route in the winter takes five hours, approximately three hours to salt only. This only gets longer in the event of illness or other issues. This has an impact on everyone who lives or travels through our township in the winter.

Our township roads are chip and seal; they will continue to wear and deteriorate if they are not resurfaced on a regular schedule. We should be resurfacing a minimum of 12 miles per year to keep our roads in good shape. This process requires our road crews to repair any bad spots or holes prior to resurfacing. Given current restraints we made necessary repairs but have not resurfaced a single mile of road in 2022 or 2023. Below is a chart that represents just a few common items needed by the road department and the increase in cost.

Without levy funding, we will continue to fall further and further behind leading to deteriorating roads, equipment, and the end result is deteriorating service to our residents. We hope you will consider this information when you head to the polls come November 7th. Trustee Talk: **From Trustee Sean Roseman**

Lawrence Township Park

Well, yet another year has flown by again, and what an exciting year 2023 has been for the township. Last year the township asked the community for suggestions on what to use the American Rescue Plan Act (ARPA) funds for. Most of the suggestions were to invest in Lawrence Township Park. So, the trustees have updated the playground equipment, and added a large asphalt parking lot that was once a grass field. Only the base asphalt was installed so later it can be chip and sealed or a finish layer of asphalt can be installed. The final major project for the park will be the addition of restrooms that will be added to the existing pavilion. The new restrooms will be heated and will be open the hours of the park. Until becoming a trustee, I had no idea how much the park and walking path were used. There are not too many times you drive by without seeing someone using the park; and, that is why we believe investing these funds, that we normally would not have, in making the park a better place for families to enjoy. Again, these improvements are not being funded by your county real estate taxes.

Lawrence Township Levies

Now, let's talk about taxes. Please don't forget to exercise your right to vote on November 2nd. The township has several levies on the ballot this fall. These are the same levies and millage that were approved five years ago. Yes, nobody likes the word "taxes," but this is how this great township is funded. We are very fortunate to have all the great services that the township has, and it does cost money to have these.

POLICE DEPARTMENT NEWS

In the election in November of 2019, there was a levy on the ballot for the police department. It was a new levy to convert us from a department that was full/part time, to a completely full-time department. The main reason, at the time, was we were losing good part-time officers to other departments who were hiring full-time. We knew if we didn't do something, we would lose more good officers. The levy was on the ballot and our residents approved the new levy! In mid-January of 2020, we promoted our four part-time officers to fulltime and have maintained our full-time status since. It is time that our levy is going to expire. It will expire in December of 2024.

A few weeks ago, the township trustees approved to place the levy on the November 2023 ballot to replace the one approved in 2019. This replacement is not a new levy but will bring it up to current values. I know levies are confusing, they are to me as well. In the simplest way I can explain it since I am not an expert, a tax levy costs a homeowner \$35.00 per year per \$100,000.00 of value. As new homes are built, people pay a little bit less, and I mean a little, since it is spread across each property in the township. The \$35.00 is reduced slightly and over the four years may have been reduced by a couple dollars. A replacement levy returns the cost to \$35.00 per year, per \$100,000.00 of value. Although this is not a new levy, it will generate additional dollars as new homes have been built and is based on current property values. This levy is important to the police department as it will allow us to continue to operate as a completely full-time department.



SOME EXCITING NEWS!

We have added a drug and tracking police K9 to our ranks. We would like to introduce Noa. Noa is a 1-year-old Belgian Malinois who is full of energy and who loves to play with her Kong and tennis balls. Noa and her handler, Patrolman Patterson began training in the beginning of September and are excited to patrol the township together. We look forward to having Noa at some community events, so you have a chance to meet her!

Noa was purchased with money collected from drug fines, seized drug money and donations from local organizations and residents. We were able to get Noa, the training and all equipment to start this project with zero levy dollars!

We hope to have your support again in November and that you had an enjoyable summer!

Lawrence Township does not require a permit to construct a fence; however, we do have regulations regarding the fence placement on your lot, as well as height restrictions. In any residential district, your fence may be a maximum of six feet tall in the side and rear yard, and a maximum of four feet in the front yard. (Note: your front yard begins at the building line of your house.) You can install a fence directly on your property line; however, we suggest that you move it in a few inches.

It is not always necessary to get a survey to install the fence. Our zoning office can provide an aerial map of your property showing property lines and usually that will help ensure the fence is installed in the correct place, however it could require a survey and the township cannot survey the property for you.

Also, always be careful not to install the fence in the road Right-of-Way. Our zoning office can also help to identify the Right-of-Way before you plan your fence. As with any deck, shed, pool or home addition project, it is always a good idea to call our zoning office for some helpful information to ensure a successful project.

LTFD Levy FAQ

What services does the Lawrence Township Fire Department provide?

Lawrence Township is an all-hazards emergency response fire department. The fire department's core functions are fire suppression, emergency medical response, hazardous materials response, fire prevention, and education. Fire department members respond to all significant events, such as ice storms, snowstorms, major electrical outages, floods, and any other emergency needs from homeowners in the community. Members of the fire department do much more than respond to emergencies. Other programs offered by the fire department include child passenger safety restraint installations, babysitting classes, smoke alarm installs, CPR and defibrillator training, and fire extinguisher training.

How busy is the Lawrence Township Fire Dept?

Lawrence Township Fire Department has seen a 105% increase in calls in 10 years. (2012: 876 incidents, 2022: 1,795 incidents)

How much does an ambulance cost?

New ambulances have increased by 45% in 11 years. In 2012, we purchased an ambulance for \$174,973; today, the same ambulance purchase was \$254,000.

Is the Mill Value the same everywhere?

No, the value of a mill is different for each community based on property values. For example, Lawrence Township 1 mill only produces approximately \$252,000 versus Canton Townships approx. \$417,000, Perry Township's approx. \$730,000, and Plain Township's approx.\$1,700,000.

Does the Fire Department use volunteers?

No, unfortunately, the use of volunteer firefighters stopped years ago. The State of Ohio has seen fewer volunteer firefighters due to a lack of interest, training requirements, and time constraints. We currently utilize part-time and paid-per-call staff. How is the fire department staffed? We strive to staff four (4) part-time EMTs a day.

How many full-time members do you have? We have one (1) full-time member responsible for fire inspections and administrative duties.

How many fire levies does the Township have? We have five (5) fire levies that support our fire department.

When did the last levy increase pass?

Are there other funding sources for the fire department?

Yes, the fire department "soft bills" for EMS calls.

What is Soft Billing?

Soft billing occurs when the patient's insurance company is billed for services, the fire department accepts whatever the insurance carrier pays, and our agency writes off the bill's balance. The soft billing occurs for township residents only. Non-residents are charged the full amount for services regardless of the insurance coverage.

Do insurance companies pay the full amount charged for service?

Almost all insurance companies, including Medicare/Medicaid, will only pay a contracted amount; the balance is the patient's responsibility. For example, the cost of ambulance care/transport is \$900, and insurance is only contracted to pay \$400; the balance is the insured's responsibility.

Yes, the demand for service increases for a variety of reasons. The need to be more diverse in services rendered/called for, an aging community, heavier traveled roads, and specific community demands are all factors that affect calls for service.

FALL AND WINTER REMINDERS

Where did summer go? I can't believe fall is here and before long winter will come snarling and howling into the picture.

Leaf Pickup: There will be no leaf pickup in the township this fall.

Mailboxes: Check now for rotten posts and make sure the box is screwed on tight. If snow coming off the plow hits your mailbox and knocks it over, we are not responsible for replacing it.

Christmas Tree Pickup: There will be no Christmas Tree pickup in the township this winter.

Basketball Hoops, Etc.: Please remove all basketball hoops, etc. from the roads, especially in the cul-de-sacs. This enables the snowplows to maneuver properly to clear the snow and salt the pavement.

When Will the Township Plow My Street? The township has approximately 58 miles of roads. Roads are plowed giving priority to main roads, followed by secondary roads, then dead-end roads and cu-de-sacks.

Salting Roads: In an average snowfall of two to four inches, it takes four hours for our crew to spread the first application of salt on all township roads. That first application of salt is crucial to prevent the snow from bonding to the pavement.

Plowing, Snow Less Than Six Inches: Snows with accumulations of less than six inches should allow the crew to plow every street within eight hours after the storm has ended, providing there is no wind involved that would cause drifting snow.

Plowing, Snow Six Inches or More: With a storm of six inches or more, it usually takes eight hours after the storm has ended to get through every street. During a very heavy snowfall, snowplows may need to be rerouted from secondary roads repeatedly to concentrate on keeping the main roads open. This can cause delays. Wind again is a factor; with wind you could go out every three to four hours to plow drifting snow. Equipment breakdowns should also be taken into consideration as no matter how well we have taken care of our equipment, problems can and do occur.

Missed Streets: If your street has not been plowed after the period of time indicated above, please call the Township Road Department and leave a message as we will probably not be in our office or call the administrative office or any of your trustees. These numbers are all listed in this newsletter.

Why Does My Driveway Get Plowed Back In? We make every effort to clear roads and storm drains to prevent icing conditions if remaining snow melts and refreezes. Snowplows are angled to the right. You can help by shoveling snow to the right of your driveway or into your yard. It's the best way to minimize the amount of snow that may get plowed back into your driveway.

A Few Additional Safety Tips

We can clear the roads faster and better with your help. The following information may make your travel during severe weather safer.

- Do not tailgate snowplows! Stay at least two car lengths behind. Never cut between a caravan of plows clearing the highway.
- During ice storms, beware of possible power outages affecting traffic signals, downed tree limbs and other debris.
- Beware of "black ice" where roads may appear to be wet but are actually glazed with ice.
- Keep in mind that bridges, ramps, overpasses, and roads in low-lying areas tend to freeze first.
- If possible, stay off roads during inclement weather. If you must go out, take caution and allow plenty of extra time and braking distance.
- Let someone know your travel plans and tell them you will call when you arrive.

DID YOU KNOW?

Lawrence Township has an Emergency Snow Resolution

(Resolution 99-364) in place that limits or prohibits residents from parking on township streets or highways when a snow emergency has been declared. A snow emergency will be declared only when two or more inches of snow has fallen within an hour. This order will be issued when the regional forecast for the weather indicates several days of heavy snow. It will be posted on our website and Facebook.
